- 2) The firms will be required to demonstrate / exhibit the necessary experience/expertise and resources to satisfy the University Administration of the firm's ability to comply with this tender.
- 3) Incomplete or Conditional Tender will be rejected.
- 4) Telegraphic / Telephonic requestwill not be entertained for issuance of bid documents
- 5) Bidding documents in proper sealed envelope will be received in the Office of theProject Coordinator (PMU), Main Campus, UOSduring working hours and upto 1400 hours on March 30, 2022 and will be opened on the same day in the presence of authorized representatives of contesting firms, (who care to be present) at 1430 hours, at Committee Room of Building & Works Department, main campus, University of sargodha, Sargodha.
- 6) All the Firms will be bound for strict compliance of all terms and conditions issued by University of Sargodha and other GovernmentalAuthorities (FBR, PPRA, PRA etc.) from time to time.
