The terms and conditions / procedure of pre-qualification are given below:

- Pre-qualification documents shall be issued by the office of the undersigned at Main Campus UOS, upon written request on proper letter head (Photo copy/computer print not acceptable) and on the submission of requisite fee in the shape of bank draft in favour of Treasurer, University of Sargodha as document cost (Non-refundable).
- The firms will be required to demonstrate / exhibit the necessary experience and resources to satisfy the University Administration of the firm's ability to comply with this procurement.
- The aspiring firms / contractors must submit their complete profile including but not limited to year of establishment, full address, partnership deed and telephone numbers of persons duly authorized by the firm with whom future correspondence can be made.
- Telegraphic / Telephonic request will not be entertained for issuance of pre-qualification documents.
- All the Firms will be bound for strict compliance of all terms and conditions issued by University of Sargodha and other Governmental Authorities (PPRA, FBR, SECP, PRA etc.) from time to time.
- Connivance / Negotiations during process are strictly prohibited. If any firm is found involved in such practice, corresponding firm will not be considered.
- Particulars of equipment, tools & plants and complete bio-data of technical staff engaged by the firm / contractor with verified ownership documents must be provided in the profile.
- To substantiate the financial soundness of the firm / contractor, a certificate from chartered accountant firm and copy of up to-date balance sheet must be furnished.
- Detail of similar nature works (equal and greater amount) in-hand and executed during last five years indicating project cost, scope
 of work with verification certificate from concerned authority regarding satisfactory completion in original time limit and extended
 time limit (if any) with reasons must also be furnished.
- Detail of any arbitration / litigation or similar proceedings against any Government, Semi Government or Autonomous departments showing extent and results must also be provided.
- Undertaking on Judicial paper that the firm was never black listed by any of the Government, Semi Government organization must be furnished.
- Partnership deed / articles of association in case of company / limited firm must also be provided.
- Income tax / Sales tax registration certificate must also be provided.
- · Any further particulars, the firm wishes to furnish must also accompany the pre-qualification document.
- Any further information/detail in this connection may be obtained from the office of the undersigned on any working day before submission date.
- The competent authority reserves the right to reject the pre-qualification profiles as per PPRA Rules.
- · In case of any concealment or incomplete information, pre-qualification application will not be considered.
- Applicant Firm / contractors are required to give guarantee / undertaking that they have carefully studied the pre-qualification notice as well as pre-qualification document and they will abide by the rules and regulations.
- No fake documentary evidence must be provided and if a document is found fake, the corresponding pre-qualification request will be rejected.
- Only pre-qualified firms will be invited to participate into the tenders.
