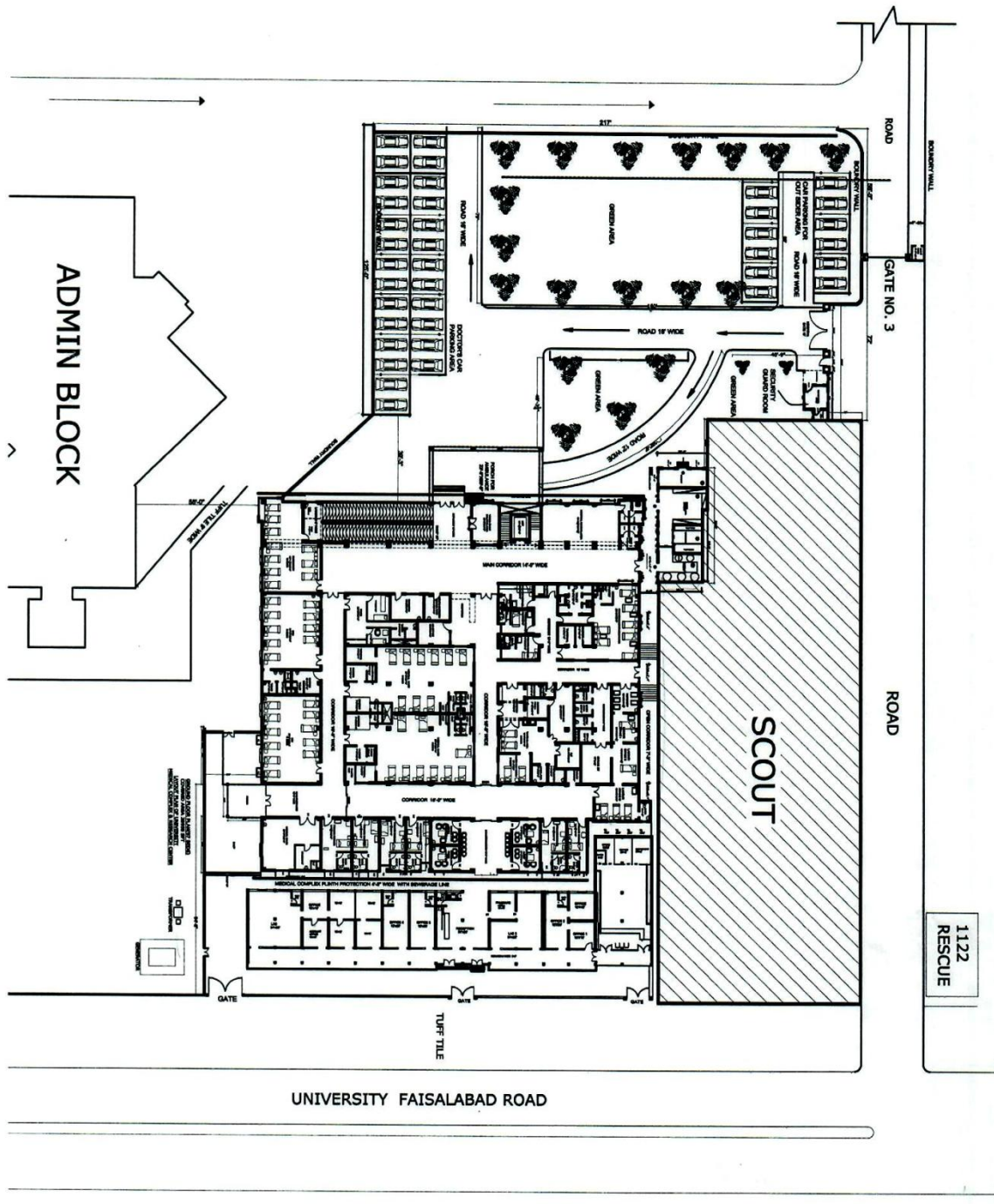

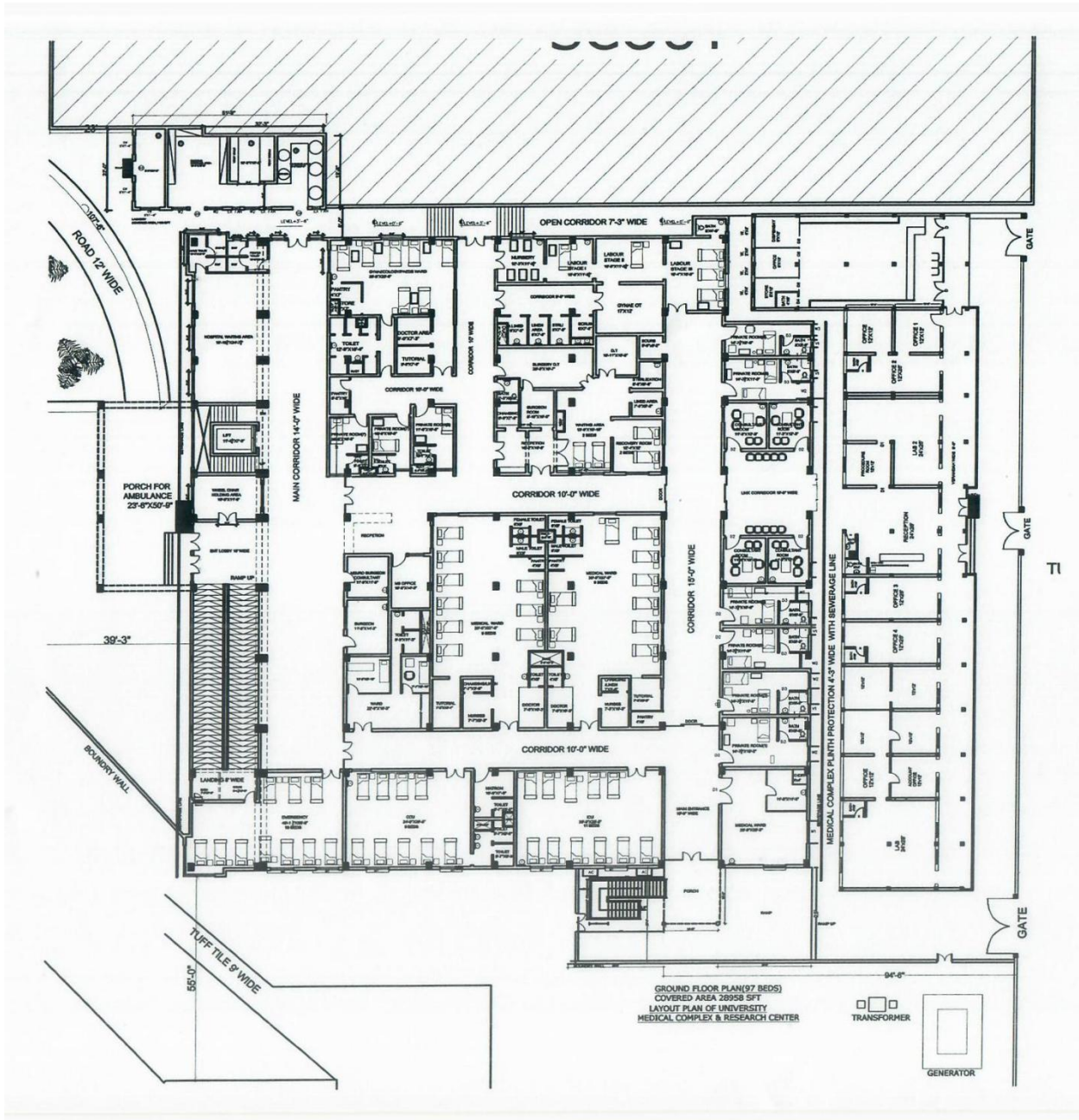

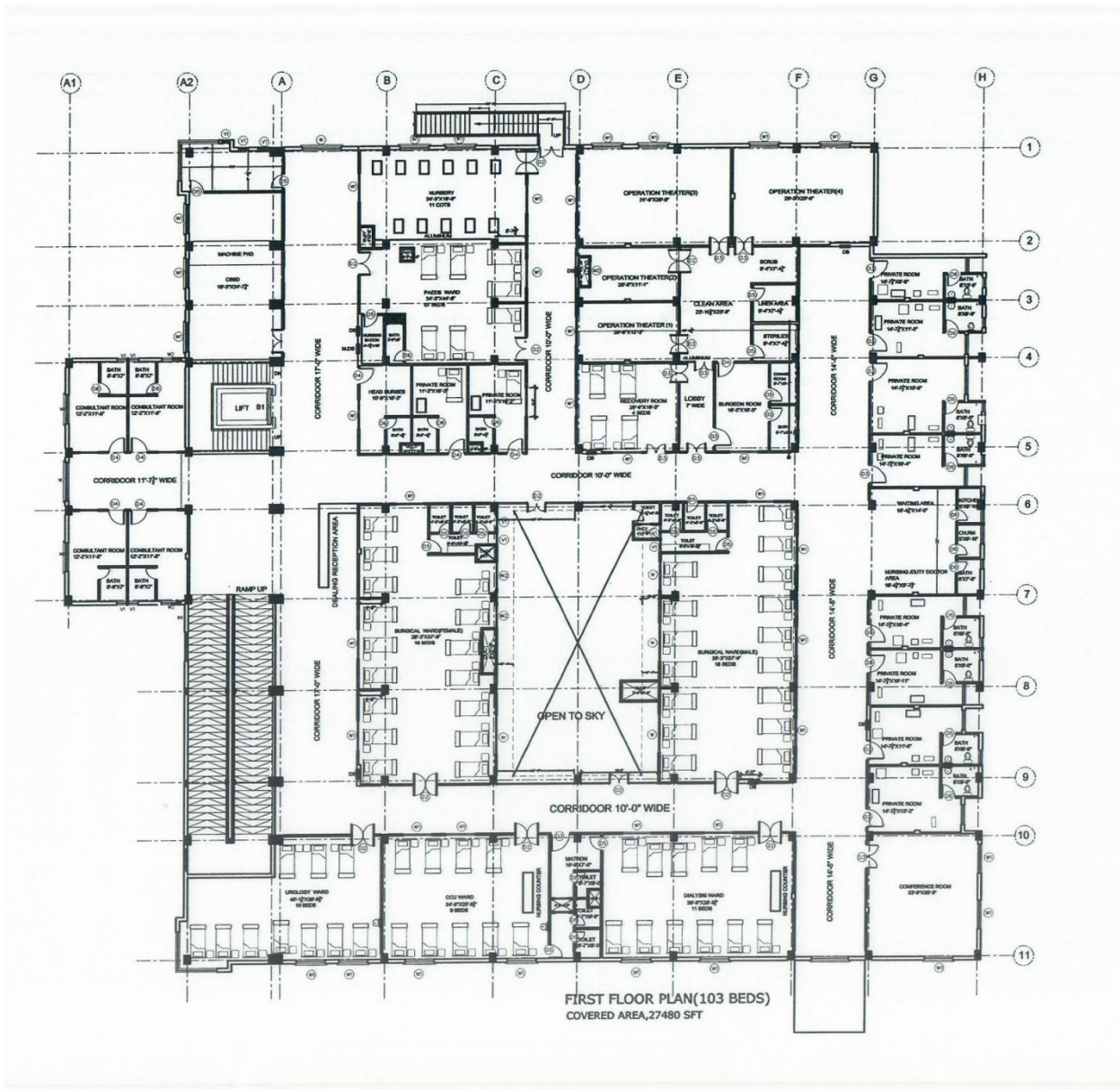
Master Plan of Al-Kindi Block (UMC&RC)
