- 3. Sending unsolicited mail, virus or making any sort of harmful activity on network is forbidden and will be considered as violation.
- 4. Privilege to Internet access will be through registered device and one device will be registered at a time.
- 5. I understand that I shall be responsible for use of this network and internet traffic generated from my computer and all contents contained in my computer/device. For data and network security, I shall ensure presence of updated antivirus/security software in my computer/device and University will not be responsible for my system/data loss.
